Notes for Applicants:

1. A total of 450 residential units will be offered by the Urban Renewal Authority (“URA”) for sale in this Starter Homes Pilot Project for Hong Kong Residents (“the Project”). Each eligible applicant who is invited for flat selection may purchase one of the residential units in the Project subject to the terms and conditions in the Application Guide of the Project (“Application Guide”).
2. Applicant must be at least 18 years old and must have lived in Hong Kong for at least 7 years on the closing date of application (i.e. 23 January 2019). His/ Her stay in Hong Kong is not subject to any conditions of stay (except the condition on the limit of stay).
3. Please read the Application Guide carefully before completing this application form.
4. Applicant who is interested in purchasing a residential unit under the Project should submit his/ her application form within the Application Period in one of the following manners:
 - i. Through Online
Submit application and pay the application fee of HK\$240 online through the website: www.eresidence.hk. For details, please refer to the above-mentioned website. If you have successfully submitted an online application, please do not submit the application form again by mail or in person. Otherwise it will be treated as a duplication of application. Should duplicate applications be found, URA reserves the right to cancel all related applications. The deadline for online application is 7:00 p.m. on 23 January 2019. **(Applicant must complete filling in all the requested information and press the ‘Submit Application’ button before the deadline);**

 - ii. By Post or By Hand
Fill in the application form in English BLOCK CAPITAL LETTERS and in Chinese (if applicable) with a black ball pen. Please sign against each amendment, if any. No correction materials such as correction fluid or tape for obliteration should be used. Please submit the completed application form together with **a crossed cheque or cashier’s order for application fee of HK\$240 made payable to “URBAN RENEWAL AUTHORITY” (Please write down the name and the contact number of the applicant at the back of the cheque or cashier’s order.** Cash, post-dated cheque or electronic cheque will not be accepted. All applications with dishonoured cheques/ cashier’s orders or without cheque/ cashier’s order will be cancelled.):

Please indicate “Application for Urban Renewal Authority Starter Homes Pilot Project for Hong Kong Residents” on the cover of the envelope. The closing date for application is 23 January 2019 as determined by the postmark. Those applications with postmark date after the closing date of the application period will not be accepted. Applications which are delivered belatedly or returned to the applicants due to insufficient postage will not be processed; or
 - by dropping in the collection box for application forms at Urban Renewal Resource Centre (Address: G/F, 6 Fuk Tsun Street, Tai Kok Tsui, Kowloon). The service hours of the collection box are from 10:00 a.m. to 7:00 p.m. daily from 3 January 2019 to 23 January 2019. The closing time for collection of application forms is 7:00 p.m. on 23 January 2019.
5. Applications submitted before or after the Application Period or not in the manner as specified above will not be accepted. No supporting documents are required to be submitted together with the Application Form. Supporting documents shall only be submitted upon request by URA.
6. Any person can only be listed in one application form under the Project (including online application). **Should duplicate application be found, URA reserves the right to cancel all related applications.**
7. All information provided should be true and correct, otherwise URA reserves the right to cancel such application. **All paid application fees will not be refunded nor be transferred.**
8. URA reserves the right not to accept any application.
9. The assessment of the application will be handled by Hong Kong Housing Society (“HS”).
